



Young Musicians & Artists (YMA) is the west coast's premier music and arts summer residential program. YMA seeks applicants for the following position:

STUDENT NURSE/MED TECH/CNA/MA

This job description is intended to provide one a basic outline of the Student Nurse/Med Tech/CNA/MA. It is by no means an all inclusive description as some duties may be reassigned and other duties assigned as required.

Position Purpose:

The Student Nurse/Med Tech/CNA/MA will evaluate and treat campers and staff for minor injuries and illnesses under RN supervision, ensure implementation of medication policies and procedures at camp, keep a log of Health Center visits, and identify health problems serious enough to require a provider's attention.

Essential Job Functions:

- Caring for the medical needs of campers and staff at camp, under RN supervision.
- Be a part of the health team for approximately 160 campers and 50 staff.
- Provide medical attention to campers and staff with general health concerns and document visits in the health center software.
- Distribute and record camper medications.
- Maintain Health Center records and medical forms.
- Communicate specific camper health needs (allergies, special diets) to staff.
- Communicate with Camp Directors and RN about camper health issues.
- Schedule appointments for sick/injured campers or staff to the hospital or clinic.

Other Job Duties:

- Act as a liaison with local providers, hospitals, and pharmacies.
- Be present at the session registration to collect medications.
- Safeguard the camper's prescription medications; administer the medications at the prescribed dosages and hours.
- Participate in camp activities and events as needed.
- Communicate and cooperate with all staff. Express any concerns in a professional manner at an appropriate time. Maintain high standards of health and safety in all activities for campers and staff.

Equipment Used:

The Student Nurse/Med Tech/CNA/MA will use the computer to access the electronic health record system to log and keep track of medications. YMA uses Campbrain. Previous knowledge of Campbrain is not required.

Responsible To:

Reports to Camp RN.

Qualifications: (Minimum Education and Experience)

- Currently enrolled in nursing program OR experience as a med tech, CNA or MA
- Flexible – able to adapt to different environments and schedules.
- Responsible, hard-working.
- Good bedside manner, friendly and personable.
- Prior medical setting experience.
- Desire and ability to be a team player.
- Ability to interact with youth ages 10 - 18.

Physical Aspects of the Job:

- Ability to verbally communicate and work with youth and provide necessary instruction to campers and staff.
- Ability to visually and auditorily observe camper and staff behavior, assess its appropriateness, enforce relevant safety regulations and emergency procedures, and apply appropriate management techniques.
- Visual and auditory ability to identify and respond to environmental and other hazards related to the activity.
- Physical ability to respond appropriately to situations requiring First Aid. Must be able to assist campers in an emergency (fire, evacuation, illness, or injury) and possess strength and endurance required to maintain constant supervision of campers.
- Endurance including prolonged standing, some bending, stooping, walking long distances; requires normal range of hearing and eyesight to record, prepare, and communicate appropriate camper activities/programs and the ability to lift up to 50 pounds.
- Willingness to live in a camp setting and work irregular hours with limited or simple equipment and facilities; and with daily exposure to the sun and heat.
- The YMA Wellness Center is a shared space managed by the Camp RN and the Mental Health Support Specialist. It is expected that these roles work to support each other when possible.

YMA's mission is to provide young people with a unique personal experience in the visual and performing arts, where they share creative interest in a positive environment that builds confidence, enhances self-esteem and reinforces a sense of community. We are committed to creating a safe, supportive environment for all members of our community, regardless of gender, orientation, race, color, religion, national origin, immigration status or disability.

Dates of commitment: June 21st - July 19th, 2024. Several pre-planning Zoom/phone meetings with the Camp RN and Director are also required.

Compensation: This is a contracted position with a stipend of \$3000, plus all meals and housing. All staff also receive reduced tuition for any children attending YMA.
